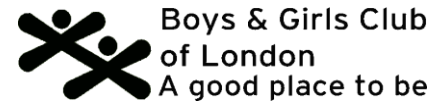


School Age Bus Program Registration Form

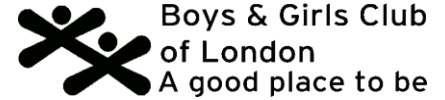

TERMS OF SERVICE

CODE OF CONDUCT:

Welcome new and returning participants! To ensure a safe travel for all, please review with your son/daughter our Code of Conduct. Everyone must abide to the following rules; this service is a privilege to use.

As a participant involved in activities at the Boys & Girls Club of London:

1. I have permission from parent and/or guardian to ride the Boys & Girls Club bus.
2. I must conduct myself in a manner which reflects positively on my peers, the Boys & Girls Club and myself.
3. My safety and the safety of others, while on the bus, reflect on my actions.

In order to attend and continue to ride the Boys & Girls Club Bus, I will:

1. Have no physical contact or harassment with anyone. Always use appropriate language, no swearing or teasing to others;
2. Remain seated at all times. Once a seat has been chosen, I will not switch seats. I will not consume food or drink on the bus;
3. Follow the instructions given by BGCL staff members, the bus driver, the bus monitor or other community members in a respectful manner;
4. Be a positive role model for my peers at all times, especially on the bus;

If I break any of these rules, I understand the following consequences will happen*:

Consequence 1: Receive a Verbal warning of loss of bus privilege. Parent is contacted

Consequence 2: Lose bus transportation for the following week. Parent is contacted.

Consequence 3: Lose bus transportation for the remainder of the school year. Parent is contacted.

*Depending on the severity of the action, we may implement Consequence 2 or 3 before the Consequence 1.

Additional Information / Bus Rules

- Our bus service is a Free Extra Service provided by the Boys & Girls Club for member in grades 1-8.
- Any unmanageable behaviour, such as fighting, disrespectfulness to anyone or vandalism will involve meetings with parents, behaviour contracts or suspensions.
- A completed Bus Registration Form must be handed into the BGCL before a child may use the BGCL bus service.
- **Pick-up times may be later due to weather or traffic.** Bus departure times are rigid. We cannot alter the bus schedule or locations to meet the needs of individuals.
- If a bus is missed, parents/guardians are required to transport their child home.
- **If your child is not returning home on the bus, please notify the bus monitor or receptionist immediately.**

GENERAL WAIVER:

I, the undersigned, the parent/guardian of the above named child do hereby consent to this child's participation in the Boys & Girls Club of London's programs.

I acknowledge that participation in these programs involves light to vigorous activity and includes the possibility of injury.

I grant program officials the authority to obtain emergency medical treatment as necessary to ensure that the above named child is safe from further injury.

I am aware of no physical or other reasons why this child should not participate in club programs and related club functions. The risk of sustaining injuries results from the nature of the activity and can occur without any fault of either the Member, or the Club, its employees/agents or the facility where the activity is taking place. By choosing to take part in this activity, I am accepting the risk that my child may be injured.

The Boys and Girls Club of London does not provide accidental death, disability, dismemberment or medical expense insurance on behalf of the participants in this activity.

In consideration of the Boys & Girls Club of London allowing this child to participate in Club programs, **I agree to waive and release Boys & Girls Club of London, its employees, volunteers, directors and agents (the "Releasees") from all claims for damages, injury or loss that may arise as a result of my child's participation in programs, including those arising from the Releasees own negligence (i.e. a failure to take reasonable care). I will impress upon the child the importance of following Club rules, regulations and instructors directions.**
